Will my social event charge an entrance fee?

KEEP IT SAFE AND LEGAL



We want your fundraising to be as much fun as possible but it's got to be safe and legal too, adhering to rules set out by the relevant authorities.

Your fundraising efforts should make it clear you are raising money 'in aid of Ferring Country Centre'.

Raffles

Raffles do not require a licence if you sell tickets at the event, on the day. You can hold a sweep stake or a tombola too. Tickets need to be the same price. You can check the full regulations at www.gamblingcommission.co.uk



Collections

You must obtain a permit to collect money in a public space, house to house or on the street. This includes shopping centres and supermarkets. If you are collecting on private land or at your own event you must seek permission of the landowner. All monies raised are 'in aid of Ferring Country Centre'



Licences

Some events require a licence. If you are selling alcohol or playing music you may require a temporary licence. Check with your venue and the local authority.



Food Safety

Whether you are basking at home or holding a BBQ you need to follow food safety guidelines, to ensure hygiene standards are maintained. You can contact www.food.gov.uk for more information.



Insurance

Ferring Country Centre cannot accept any responsibility for accident, injury or loss. Please check you have adequate cover for the level of risk your event poses. All events involving the public must have public liability insurance. Ask your venue – it may already be in place. You must take reasonable steps to ensure the safety of everyone involved.

Emergencies

You must ensure there is an adequate level of first aid cover for your event. Your venue may provide this. You can check with your local authority to ensure you have adequate cover. They will happily signpost you to organisations that can help with this. Have first aid kits available.



The Money

If possible, count cash with another person, keep in a safe place and bank it as soon as you can. You can pay by transfer to Ferring Country Centre Ltd Sort code 60-24-32, Acc no: 06502806 or by debit card in person or over the phone 01903 245078



SPONSORSHIP PAGE



Getting started: Setting up your own online sponsorship page is the easiest way to collect immediate support from family, friends and work colleagues.

There are several different fundraising platforms available but **Just Giving** is the preferred option for Ferring Country Centre.

The advantage of an online fundraising page is that you can reach more people and raise more money. It only takes a few minutes to set up and sponsorship money donated is sent directly to Ferring Country Centre. This saves time as you don't have to go around collecting all the money pledged to you. Gift Aid is also processed directly for us, which is a bonus.

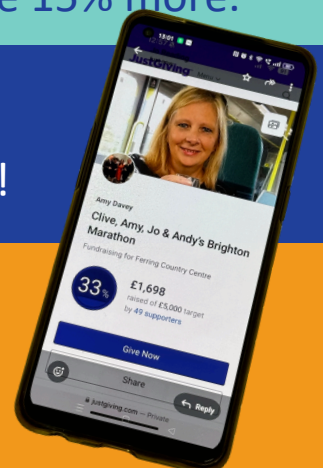

Tips for creating the perfect Fundraising Page:

Make it personal: When you set up your page, always include photos and a story. Explain why you have chosen to fundraise for Ferring Country Centre and why it is important to you. Pages with photos tend to raise 15% more.

Set yourself a target: If you set a target, you usually reach 46% more! If you reach your target you can always increase it!

Supporters: Make sure you thank the supporters who have donated to your fundraising page and ask them to share it on their social media.



SPONSORSHIP FORM



You may print as many of our paper sponsorship forms as you need (found on the next page). Give copies to your family, friends and local businesses to help you collect extra donations to reach your target.

Please remember to send these forms into Ferring Country Centre so that we can claim the Gift aid. Please check that everyone completes their name and postcode on the form.

You should aim to send your money within a month of completing your challenge.

Gift Aid:

Gift Aid is a scheme that allows charities to claim an additional 25p for every £1 donated by UK Tax Payers. Always ask your sponsors to tick the box on the sponsor form. We can only claim the Gift Aid if the sponsor's full name, address (house number and postcode)
